Jack Fritscher wrote (below) in response to his receipt of the letter above, and of the check, and of the typed manuscript mentioned. This assignment was the third volume of the translation from German by Father Kaiser of Bernard Haring's THE LAW OF CHRIST whose first two volumes, each 500 pages, Jack Fritscher had over the previous five years also edited with re-writes and new translations of troublesome passages, including final proofing of galleys. "Newman Press loved me, because I worked for nothing," he said. "I was paid \$50 per book at 500 pages per book. It seemed like a fortune then, and for a teenager it was a wonderful apprenticeship in the world of publishing. At the time of this letter, my father was well into his twelve-year illness, and I was working at every job I could to support my parents and my eight-year-old sister while I was also a graduate teaching assistant at Loyola University."

For nearly ten years (1957-1966), Jack Fritscher worked for Newman Press, re-writing, editing, and proofing many books important during that time of the Vatican Council. At age 17, he had been introduced to the Newman Press by his longtime mentor the Reverend Leonard J. Fick of the Pontifical College Josephinum.
